# Parks, Recreation and Environmental Commission October 6, 2021 City Hall Upstairs Conference Room, 6:30 p.m.

#### I. Call to Order

The meeting was called to order at 6:30 p.m. by Chair Johnson.

#### II. Roll Call:

<u>Members Present:</u> Commissioners Gary Bank, Kristin Hicks, Matt Johnson (Chair), Julia O'Rourke, Michael Spooner, and Charles Warner.

<u>Members Absent:</u> Commissioners Ahmed Abdiwahed, Pauline Alfors, Amelia Kuiper.

Also Present: Director Jennifer Fink and Council Member Emily Dunsworth.

#### III. Approval of Agenda

Motion by Bank, seconded by Warner to approve the agenda as presented. Motion carried 6-0.

#### IV. <u>Approval of Minutes</u>

Motion by Bank, seconded by Hicks to approve the September 1, 2021 minutes as presented. Motion carried 6-0.

#### V. <u>Business Items</u>

#### A. 2022 Planning – Jennifer Fink, Director of Parks and Recreation

Director Fink led a conversation to talk about work planning for 2022, which included sharing information about the number of meetings that will need to be dedicated to park projects. She asked if the Commissioners had any specific topics that they would like to discuss in the coming year.

Councilmember Dunsworth discussed how the Council would like to work more collaboratively with its Commissioners and hear the issues the City should be completing in the coming year.

Discussion included:

- The Commission supported discussing park facilities in 2022 in order to address sustainability and other initiatives for each park building.
- The Commission supported discussing community art in 2022. Councilmember Dunsworth noted the Equity Commission would also be addressing placemaking in the community.
- The Commission supported the City looking into connectivity with its bike trails throughout the community.
- It was noted staff would be bringing forward a discussion on additional adaptive and inclusive services at a future meeting.
- The Commission recommended sustainable landscaping and native plants also be pursued for the City within its parks.
- The Commission thanked staff for providing the group with a great list of ideas for PREC to address in the coming year.

#### VI. Announcements

#### A. <u>City Council Report - Council Member Emily Dunsworth</u>

Councilmember Dunsworth provided the Commission with an update from the City Council. She discussed the work the Council has been doing to create an Equity Statement and Equity Commission. She reported the City Council was now taking applications for Commissioners interested in serving on this Commission. She explained the Council recently received a very informative presentation from Metro Transit.

#### B. PREC Chair Updates - Matt Johnson

Chair Johnson thanked staff for all of their efforts on behalf of the community. He explained he has enjoyed attending the farmers market at the community center this summer.

#### C. Department Happenings and Upcoming Events – City Staff

Director Fink stated project meetings had begun with WSB for the park project at Hansen Park. She reported staff received a Shade Tree grant that would assist with Ash tree removal in the City. She invited the PREC Commissioners to attend Tails on the Trails at Hansen Park on Sunday, October 10 from 11:00 a.m. to 4:00 p.m. She explained a pumpkin walk was being planned for Saturday, October 30. She noted the Public Safety Department would be hosting an Open House on Monday, October 25. She commented over MEA weekend a City-wide garage sale would be hosted throughout the community. She then reviewed the number of rounds of golf that have been played at the Brightwood Hills Golf Course.

- **History:** An Inclusive Community Taskforce was created in 2018 with the purpose of creating recommendations around making New Brighton an inclusive and welcoming community. They provided recommendations to the Council regarding areas of improvement within the City.
  - The City Council approved the addition of a Diversity, Equity and Inclusion (DEI) Coordinator in the 2021 budget. Along with that, the Council approved the creation of an Inclusive Community Commission.
  - In September 2021, the City Council approved the Equity Statement, and in October of 2021 an Equity Commission was approved. Mark Suggs is hired as the City's First DEI Coordinator
  - The City received 25 applications for the Equity Commission, and interviews will be taking place in December. The Commission will be seated in January.

#### Summary:

Diversity, equity and inclusion (DEI) work is not just a priority of the City Council or a response to cultural and societal pressure. Ensuring all residents are served and treated equitably is a key function of local government and intentional work in this area is important to the success of the City. The City is working to set up a governance structure and management function that helps the City achieve equity now and into the future.

The approved Equity Statement and Framework is available on the City's website - https://www.newbrightonmn.gov/equity. The City encourages everyone to visit the site. Updates on the City's progress will be posted there frequently.

Mark has been working for a little over a month with the City, and our purpose at PREC is to introduce him to our Commission and for him to share a little bit about what he has been doing, and any potential plans he would like to share with the Commission.
