

COUNCIL PROCEEDINGS THE CITY OF NEW BRIGHTON

Pursuant to notice thereof, a regular meeting of the New Brighton City Council was held Tuesday, February 14, 2023 at 6:30 pm in the New Brighton Council Chambers.

Call to Order

Mayor Niedfeldt-Thomas called the meeting to order at 6:30 pm.

Pledge of Allegiance

Mayor Niedfeldt-Thomas led the Council in the Pledge of Allegiance.

Public Comment Forum

Mayor Niedfeldt-Thomas opened the Public Forum for comments from the public. There were no comments from the public.

Special Order of Business

1. Public Safety Annual Update

Public Safety Director Paetznick presented the Public Safety Annual Update to the City Council and stated he appreciated the opportunity to provide this information to the Council. He commented on the results of the 2022 resident survey noting crime and safety was the most frequently cited issue for residents when they named what they felt was the single most critical issue facing New Brighton. He discussed how important it was for residents to feel safe. The calls for service from 2022 were reviewed and it was noted there were 4,035 incidents with over half being medical in nature. The call category with the largest increase was for false alarms. He commented on how staff was working to address this concern. He further reviewed the numbers for Part 1 and Part 2 crimes for the past five years. He commented on how the City was in a better place when it came to property crimes and thefts. The number of motor vehicle pursuits and use of force incidents were discussed. He provided the Council with further information on the City's body worn camera policy. He encouraged residents to stay informed by visiting the New Brighton Public Safety Departments Facebook page and by reviewing the City's newsletter and website.

1. Public Safety Annual Update

Safety Director Paetznick reported the multitude of these events were occurring in the City's multifamily housing developments.

Councilmember Dunsworth questioned if the calls for suicide in progress, person in crisis or welfare checks were best for an officer to respond or could another agency or social worker respond. Public Safety Director Paetznick stated this would depend on the specific call. He reported with many of these calls, social workers would still need law enforcement to respond to ensure the site was safe.

Councilmember Allen discussed how more officers were responding to calls than in the past. Public Safety Director Paetznick commented on the calls for service in the community and discussed how certain calls require more officers to respond for the safety of all involved.

Mayor Niedfeldt-Thomas asked if the uptick in home fires was due to more people working from home or the improper maintenance of homes. Public Safety Director Paetznick stated he was uncertain was to why the community was having more fires, but noted staff would be investigating this matter further. Mayor Niedfeldt-Thomas thanked Public Safety Director Paetznick for his presentation.
